 - a. We begin our Nevada Arts Council meeting by acknowledging that we gather today from the ancestral homelands of the Numa, the Newe, the Nuwuvi, and the Wa She Shu who have lived in the Great Basin since time began. Please join me in expressing our deepest respect and gratitude to our four major Indigenous groups; the Northern Paiute, the Shoshone, the Southern Paiute, and the Washoe--not just the original caretakers of the land we now call Nevada--but for their enduring stewardship and protection of our shared lands and waterways. Today, the Nevada Arts Council reaffirms its commitment to improve the quality of life for our 27 Tribal Nations, Bands, Colonies, and the 62,000-plus Urban Indians who chose to make Nevada their current home.
