The Nevada Arts Council is proposing the Amendment of regulations pertaining to Chapter 231 of the Nevada Administrative Code. **A workshop has been set for 3:00 p.m. on Wednesday, October 16, 2019 at the Laxalt Building, 401 N. Carson Street, Carson City, NV 89701 with video to the Tourism Office at 4000 S. Eastern Ave. #240, Las Vegas, NV 89119.** The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

The Nevada Arts Council intends to amend NAC Chapter 233C to update the chapter and comply with NRS 233B.100.
